We believe in a world where no child ever has to live on the streets.







## RAILWAY CHILDREN AFRICA

Railway Children Africa (RCA) is a national NGO registered in Tanzania. As an organization, our primary aim is to enable and create positive sustainable change in the lives of children and youth living alone and at risk on the streets. Our strategy focuses on four key action areas for change to protect the most vulnerable children before, during and after they are alone and at risk on the streets.

- a. Protecting vulnerable children and supporting their families.
- b. Strengthening community responses
- c. Strengthening child protection systems and policies
- d. Strengthening the evidence base

RCA is implementing programming for children and youth living and working on the streets (CYLWS) to ensure the needs of these hard-to-reach children and youth are well addressed.

#### **BOARD MEMBER COMMITMENT:**

- A commitment to regularly attend Board Meetings and related meetings.
- Actively participate on the board and subcommittees of the board
- Prepare for board meetings by reading relevant meeting materials in advance.
- Accept assignments and complete them thoroughly and on time.
- Stay informed about matters concerning the board its subcommittees.

### **JOB DESCRIPTION**

#### **Board Director roles**

As custodians of the governance process, the collective role of the board of Directors is to provide strategic direction and constructive challenge to ensure Railway Children Africa, via its Executive Director, delivers its goals and objectives and is managed effectively. The Directors have duties and responsibilities under NGOs Act and are entrusted with the role of ensuring that assets are properly secured and deployed.

There are four board meetings per year. Directors may be invited to serve on one of the Charity's sub-committees, which each meet four times annually. Directors may also be asked to advise the executive on specific issues from time to time and may be invited to attend events.

This Directorship is unremunerated, although reasonable expenses may be claimed. The normal period of office is three years and all Directors are eligible for reappointment at the end of their term of office. In general, Directors serve three terms of office.

#### The duties of Directors are to:

- Work alongside the Directors and Executive Director to ensure that Railway Children Africa complies with its governing document (its RCA Constitution, Partnership Agreement between Railway Children and Railway Children Africa), NGOs Act and any other relevant legislation or regulations. Ensure that Railway Children Africa pursues its objects as defined in its governing document.
- Contribute actively to the Board of Directors role, working alongside other Directors in giving firm oversight and governance in relation to the strategic direction of Railway Children Africa.
- Attend Board meetings and sub-committee meetings as appropriate.
- Safeguard the good name and values of Railway Children Africa.
- Ensure the financial stability of Railway Children Africa in terms of the funding and income models for the charity.
- Actively support income generation and fundraising through the use of personal and professional networks.
- Alongside other Directors, support the Executive Director and Management Team and monitor their performance.

- Enable and support the Board in its safeguarding governance role to ensure that the development and implementation of a safeguarding framework is robust so that all those that come into contact with Railway Children Africa are protected from harm.
- Ensure good governance to ensure the organisation can move forward on the right strategic path.
- Represent the charity when appropriate.
- Support the Executive Director and Senior Management Team to harness all the talent to maximise impact across all Railway Children Africa activities.
- Ensure that the charity is following best practice in terms of its business rigour.
- Provide expertise and insight at Board meetings.
- Actively promote and embody Railway Children Africa's core values of Never give up, have courage, Earn trust, Show Compassion and Nurture Talent across the organisation and partners.
- Uphold and work within Railway Children Africa's policies and procedures.
- Undertake any other duties, as appropriate to the post.

#### Time commitments to include:

- 10 hours per year to include: Four Board meetings.
- Quarterly attendance at sub-committees and attendance at Railway Children events.
- Preparation time for meetings.
- We encourage Directors to visit our programs in order to broaden their knowledge of projects and to familiarise themselves with local conditions.
- A board member can attend the meeting online.

#### Length of term

Initial three-year term with the possibility of an extension for two further three years terms.

### PERSON SPECIFICATION

#### We are looking for people with the following background and skills:

- Someone with experience of managing programmes at a senior level.
- Someone with professional skills on child protection, NGO programming, accountancy and audit, corporate governance, management and leadership, marketing and communications, fundraising, child psychology, Human Resources, child rights and Safeguarding.
- Someone with senior experience in managing programmes or services for children, including a sound knowledge of managing safeguarding.
- A senior leader or Director of an international NGO or national NGO or retiree of the same kind of organization of a similar size with an understanding of charity governance.
- A senior person of influence in the government and donor community.

#### Skills and Abilities:

- Strong strategic skills.
- Analytical and evaluative approach to decision-making.
- Open to feedback and willing to learn.
- Respect for others and ability to work with others.
- Good judgement and strong communication skills
- Clear and sensitive communicator and able to engage and influence.
- Maintain confidentiality on confidential and/or sensitive information.
- Team player but able to express own opinions constructively and positively.
- Able to manage difficult and/or challenging situations.
- · Sound understanding of sustainability issues.
- Excellent experiential technology knowledge.

- A passion for improving the lives of children.
- Empathy with the mission and strategy of Railway Children.
